# FAQs on 32<sup>nd</sup> Annual General Meeting of the Company

# 1) What is the remote e-voting period? Or When can I vote on the resolutions provided in AGM Notice?

The Company has provided the remote e-voting facility for all the shareholders from 9.00 am Thursday, July 23, 2020, to 5.00 pm Tuesday, July 28, 2020.

Those Members, who will be present in the AGM through VC / OAVM facility and have not cast their vote on the Resolutions through remote e-voting and are otherwise not barred from doing so, shall be eligible to vote through NSDL e-voting system during the AGM.

#### 2) How do I vote on the resolutions provided in AGM Notice?

- a) The shareholders can log in on NSDL e-voting website: https://www.evoting.nsdl.com/
- b) Click on "Login" under the first left tab "Shareholder/Member"
- c) Fill up (a) User ID; (b) Select the login type: "Password"/"OTP"; (c) Verification code. Tick on checkbox and click on "Login"
- d) Go to "e-Voting" under the first left tab and click on "Active E-voting Cycles"
- e) Select the Sasken EVEN "113077" and vote on resolutions
- f) Select the options and click on "Confirm" to confirm his vote
- g) You will get voting confirmation

# 3) Which device is to be used to join the AGM?

You can join the AGM through desktops / laptops / smartphones with good internet facility. It is recommended to use 'Google Chrome' for better experience.

#### 4) How to ensure speed of internet and verify the network connectivity?

Verify your network connectivity by going to: <u>https://mediatest.webex.com</u>. Minimum download and update speed required is 2 Mbps.

The said Resolution/Authorization shall be sent to the Scrutinizer by email through its registered email address to scrutinizer@sasken.com with a copy marked to evoting@nsdl.co.in.
