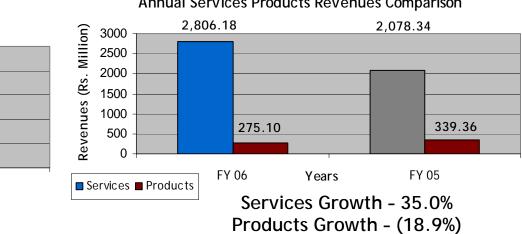

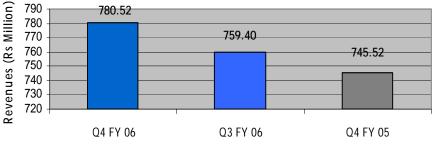

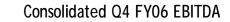


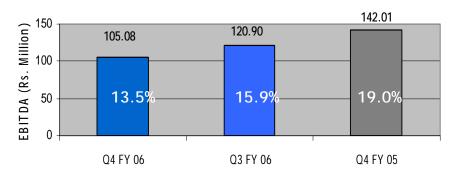




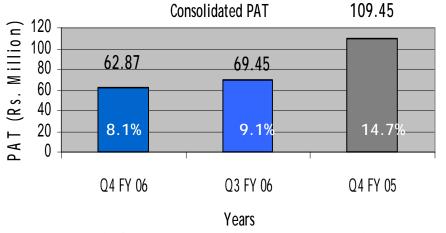
Years

Sequential Quarter Growth - 2.8%



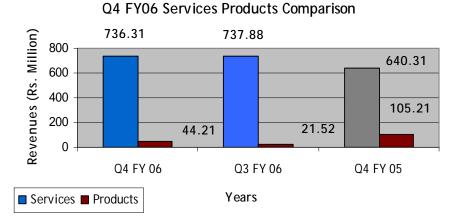


Years Sequential Quarter Growth - (13.1%)

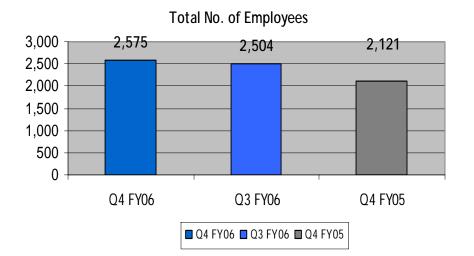


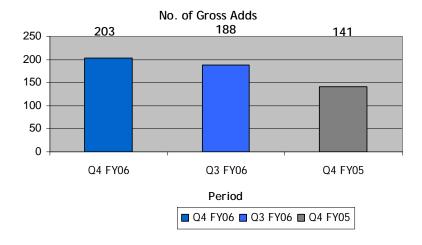

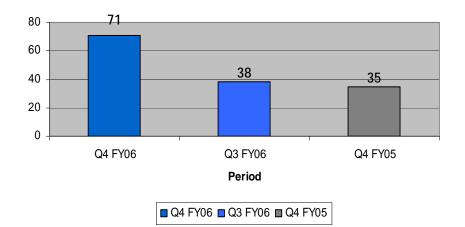
Human Resources Metrics for Q4 FY06



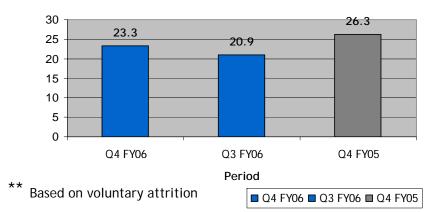




No. of Net Adds

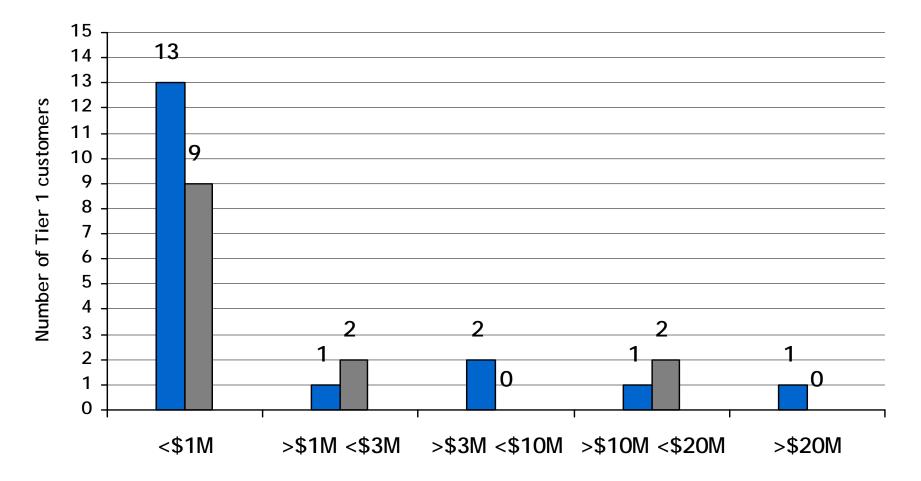
Services Revenue Mix

Relationships with Tier 1 Customers

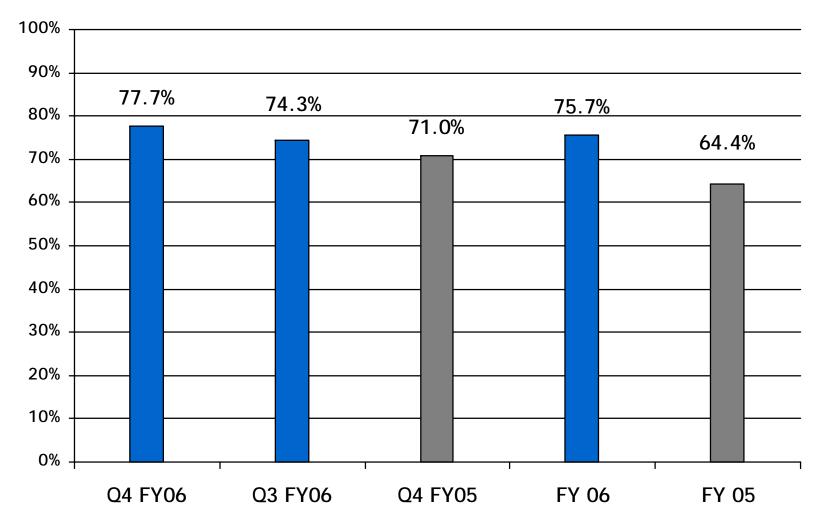


Based on trailing 12 months Services revenues in USD
